#### CALL FOR WRITTEN SUBMISSIONS FROM STAKEHOLDER BODIES AND MEMBERS OF THE PUBLIC ON THE DRAFT POLICY DOCUMENT, NATIONAL POLICY PERTAINING TO THE PROGRAMME AND PROMOTION REQUIREMENTS OF THE NATIONAL CURRICULUM STATEMENT GRADES R - 12

1. I, Angelina Matsie Motshekga, Minister of Basic Education, after consultation with the Council of Education Ministers and in terms of *Sections 3(4)(l) and 7 of the National Education Policy Act, 1996 (Act No. 27 of 1996)* and together with *section 6(A) of the South African Schools Act, 1996 (Act. No. 84 of 1996)*, hereby give my intention to amend policy and accordingly invite stakeholder bodies and members of the public to comment on the draft policy document, *National Policy Pertaining to the Programme and Promotion Requirements of the National Curriculum Statement Grades R – 12*.

#### BACKGROUND

2. The *National Curriculum Statement Grades R – 12* represents a policy statement for learning and teaching in schools located in both the General Education and Training (GET) and Further Education and Training (FET) Bands and comprises the:
  - (a) National Curriculum and Assessment Policy Statements for all approved subjects for Grades R - 12; and
  - (b) The Policy document, *National policy pertaining to the programme and promotion requirements of the National Curriculum Statement Grades R – 12*.

3. Stakeholder bodies and members of the public have been invited to comment on the newly developed National Curriculum and Assessment Policy Statements by means of *Government Notices No. 784 and No. 785* in *Government Gazette No. 33528* of 3 September 2010.
4. To reflect the principle of a single curriculum document, namely, the *National Curriculum Statement Grades R-12* which addresses both the GET and FET Bands, it was necessary to amalgamate a newly developed GET policy document and the amended FET policy document into a single policy document, namely *National policy pertaining to the programme and promotion requirements of the National Curriculum Statement Grades R – 12*.
5. The amalgamated policy document which contains both the GET and FET policies will ensure that there is only one policy document for both GET and FET.
